All rates and conditions are subject to change as required and without prior notification.

Driver requirements

The Vehicle may be driven during the term of hire only by the person(s) described in this agreement and only if each such person holds a current full driver's license appropriate for the class of vehicle in this agreement, is aged 25 or above and must have two years driving experience. The license details are recorded in this agreement alongside each person's name. If the foreign driver's license is not in English, an English translation or international driving permit shall be carried with the foreign driver's license.

Deposit/credit card

Upon collection of the vehicle, the driver needs to present a valid credit card (not digital) in the driver's name. This will be used for the security deposit. The Rental Firm will reimburse the security deposit after the final rental account has been settled, as long as the vehicle is returned as required. a) the Vehicle and its contents have been returned in the same condition as when hired; and b) the Vehicle is returned to the agreed location on the agreed date. Failure to comply

b) the Vehicle is returned to the agreed location on the agreed date. Failure to comply with this clause will result in the bond being reduced ratably and proportionately to allow the Rental Company to reinstate the Vehicle and/or its contents back to the same condition it was before commencement of the hire.

Any charges incurred in addition to the hire charge paid in advance by the Hirer will be deducted from the security deposit when the vehicle is returned.

The motorhome is covered by a statutory motor vehicle third-party liability insurance with an insurance cover (varies by country). The liability for New Zealand is NZD 7.500

The excess is set off against the security deposit. Any damage not covered by the insurance, such as for example damage caused by alcohol- or narcotics-related unfitness to drive, by leaving the vehicle to an unauthorized driver, etc., are completely at the Hirer's expense. Any damage to the interior and/or the inventory is not covered by the insurance either so that respective costs of repair or





replacement must be completely borne by the Hirer. The Rental Firm is not liable for any damage, whether direct or indirect, caused by acts of the Hirer.

require the presentation of an international driver's license (for non-EU citizens). It should be noted that some vehicles have a total weight of over 3.5 tonnes and to drive these vehicles it is required to hold an appropriate driving license. Holders of B class driving license must check with the Rental the permissible total weight of the rented vehicle.

Minimum rental period

The minimum rental period is 5 days; different minimum hire periods will vary during peak seasons.

Changes

Changes may be made to a reservation confirmed to the Hirer from the date of reservation until at least 60 days before the agreed commencement of the rental period, as long as the Rental Company has alternative capacity and the alternative booking corresponds in amount to the first. Rebooking is only possible in the same calendar year and at the same station, a change of station is not possible in case of rebooking. Later changes of bookings are not possible. If the booked travel period is shortened/reduced, the mentioned cancellation conditions apply to the cancelled nights. Each rental amendment will be charged according to the valid price list.

Picking up /dropping of the vehicle

The motor home is delivered in a clean condition, with a full tank and equipped according to the inventory list submitted and must be returned in the same condition. If that is not the case, the Rental Firm shall be entitled to charge an amount for the cleaning of the interior. If the tank of the

vehicle should not have been filled up, we charge the petrol costs as well as cost of work (€25). Any missing or defect items of the inventory list will be invoiced to you. Any possible retention will be set off against the security deposit.

The pick up time is from 12pm till 3pm from Monday till Friday, and Saturday pick up and drop off is between 10am and 1.30pm. Drop off time is from 9 till 11am from Monday to Friday. Saturday is same as pick up times 10am and 1.30pm.

Vehicle Size / Layout

McRent only guarantees a specific group, NOT a specific vehicle. Layouts and sizes may vary. If it is not possible for McRent to provide a vehicle of the booked group at Pick-Up:

- 1.) a vehicle of an equal or higher category is provided
- 2.) a vehicle of a lower category is provided and the price difference is credited
- 3.) a vehicle at a different location is offered. Any extra charges are borne by the customers
- 4.) If 1. 3. is not possible, the Rental Company reserves the right to cancel the rental free of charge

Travel restrictions

Journeys abroad are not permitted.

Parking/Traffic Violations

All costs incurred as a consequence of criminal activities or traffic offences committed by the hirer or a passenger will be collected by the hirer. Any fines imposed are charged to the hirer's account.

Pets and animals

In view of the experience we had in the past, it is not allowed to carry along any pets in the motorhome, unless with the prior approval of the Rental Firm.

Smoking

Smoking is not allowed in our vehicles.
