All rates and conditions are subject to change as required and without prior notification.

#### **Driver requirements**

The Hirer and any other driver must be at least 21 years old. For Vehicles above 3,5 tons the minimum age is 21 years. The Hirer and any other drivers must have been in possession of a Class III / Class B or comparable national driver's license for at least one year – for Vehicles above 3,5 tons not less than 3 years – corresponding to the weight of the Vehicle. The delivery of the Vehicle requires the presentation by the Hirer and/ or driver(s) of the driver's license and the valid identification card/passport at the time of taking possession. If a delay in taking possession occurs due to the non-presentation of said documents, such delay shall be at the expense of the Hirer. If such documents cannot be presented at neither the agreed time for taking possession, nor within a reasonable grace period thereafter, then the Rental Company shall be entitled to withdraw from the contract according to cancellation fees. The Rental Company or the official authorities of the country may require the presentation of an international driver's license (for non-EU citizens).

Please note that some of the Rental Company's Vehicles have a total weight of more than 3.5 tons and that to drive these Vehicles an appropriate driver's license is required. Those in possession of a Class B driver's license must consult the Rental Company about the engine size and the technically permissible total weight of the Vehicle rented. If, upon renting, a respective driver's license cannot be presented, the Vehicle shall be regarded as not collected. In such case, there shall apply the respective terms of cancellation. A Digital drivers license is not allowed

## **International driving licenses in Europe**

Please be aware that all drivers need to present one of the following driving licenses at Pick-Up at a rental location in Europe:

- Local driving license (issued in the country of Pick-Up)
- EU driving license (issued in a member state of the EU or the European Economic Area)
- International driving license together with the original local driving license

The original documents need to be presented. A copy is insufficient.





## **Deposit/credit card**

Upon collection of the vehicle, the driver needs to present a valid credit card (not digital) in the driver's name. This will be used for the security deposit. The Rental Firm will reimburse the security deposit after the final rental account has been settled, as long as the vehicle is returned as required. Any charges incurred in addition to the hire charge paid in advance by the Hirer will be deducted from the security deposit when the vehicle is returned.

The motorhome is covered by a statutory motor vehicle third-party liability insurance with an insurance cover (varies by country). The liability for Romania is EUR 900,-

The excess is set off against the security deposit. Any damage not covered by the insurance, such as for example damage caused by alcohol- or narcotics-related unfitness to drive, by leaving the vehicle to an unauthorized driver, etc., are completely at the Hirer's expense. Any damage to the interior and/or the inventory is not covered by the insurance either so that respective costs of repair or replacement must be completely borne by the Hirer. The Rental Firm is not liable for any damage, whether direct or indirect, caused by acts of the Hirer.

require the presentation of an international driver's license (for non-EU citizens). It should be noted that some vehicles have a total weight of over 3.5 tonnes and to drive these vehicles it is required to hold an appropriate driving license. Holders of B class driving license must check with the Rental the permissible total weight of the rented vehicle.

#### Minimum rental period

The minimum rental period is 7 days; different minimum hire periods will vary during peak seasons.

## **One-ways**

There are no one-ways possible in Romania

#### **Changes**

Changes may be made to a reservation confirmed to the Hirer from the date of reservation until at least sixty days before the agreed commencement of the rental period, as long as the Rental Company has alternative capacity and the alternative booking corresponds in amount to the first. Rebooking's only possible in the same calendar year. Later changes are not permitted. Each rental amendment will be charged according to the valid price list. After conclusion of the contract the Hirer is not entitled to any changes with regard to begin of term of rental.

## **Cancellations**

## Picking up /dropping of the vehicle

The motor home is delivered in a clean condition, with a full tank and equipped according to the inventory list submitted and must be returned in the same condition. If that is not the case, the Rental Firm shall be entitled to charge an amount for the cleaning of the interior. If the tank of the vehicle should not have been filled up, we charge the petrol costs as well as cost of work (€25). Any missing or defect items of the inventory list will be invoiced to you. Any possible retention will be set off against the security deposit.

## **Vehicle Size / Layout**

McRent only guarantees a specific group, NOT a specific vehicle. Layouts and sizes may vary. If it is not possible for McRent to provide a vehicle of the booked group at Pick-Up:

- 1.) a vehicle of an equal or higher category is provided
- 2.) a vehicle of a lower category is provided and the price difference is credited
- 3.) a vehicle at a different location is offered. Any extra charges are borne by the customers
- 4.) If 1. 3. is not possible, the Rental Company reserves the right to cancel the rental free of charge

## **Travel restrictions**

Journeys abroad but within Europe are permitted. Journeys to countries outside of Europe are subject to the prior approval of the Rental Company. Journeys to areas affected by war or crisis are prohibited. The applicable entry requirements can be found on our website:

## **Parking/Traffic Violations**

All costs incurred as a consequence of criminal activities or traffic offences committed by the hirer or a passenger will be collected by the hirer. Any fines imposed are charged to the hirer's account.

#### **Pets and animals**

In view of the experience we had in the past, it is not allowed to carry along any pets in the motorhome, unless with the prior approval of the Rental Firm.

## **Smoking**

Smoking is not allowed in our vehicles.
