

Rental conditions Rent Easy Greece

All rates and conditions are subject to change as required and without prior notification.

Standard inclusions

- 250 kilometer per day for short rentals
- Unlimited kilometers included for 15 days or more
- Deductible of € 1500,-
- Navigation
- Satelite dish, TV, Review-camera (except city)
- Bicycle rack (not suitable for e-bikes)
- Awning
- Outside cleaning

Camper is exclusive of

- Bed linen
- Dish set
- Towel set,
- Camping set (chairs and table)

Driver requirements

The prerequisite for hiring and driving the vehicle is a minimum age of 21 years. For vehicles above 3.5 tons, the minimum age is 25 years.

The renter and any other drivers must have been in possession of a Class III / Class B or comparable national driver's license for at least three years. For vehicles above 3.5 tons, the driver must have been in possession of a class C driver's license for at least 3 years corresponding to the weight of the Vehicle.

The renter must have valid identification and credit card at time of pick up. If the renter doesn't have the documents present, nor within a reasonable grace period thereafter, then the Rental Company shall be entitled to withdraw from the contract. The cancellation fee shall apply.

Deposit/credit card

The renter shall pay the lessor a security deposit of €1,500.00. The security deposit shall be paid by EC card, MasterCard or Visa Card on collection of the vehicle at the latest. Payment of the security deposit with a credit-based pre-paid credit card, digital credit card or in cash is not possible.

Minimum rental period

There is a minimum of 7 nights

One-ways

One-way rentals are only possible by special agreement.

Changes

Up to a maximum of 60 days prior to the originally agreed start of rental, the renter may change vehicle, if there is capacities and as long as this does not reduce the total rental price. A handling fee of €50.00 per booking change will be charged for this. Booking changes at a later date are not possible. However, the renter has the option of cancelling and then rebooking but cancellation fees will apply. There is no legal right to a change in the booking or in the data.

Cancellations

The charge for cancelling is:

50 days or more prior to pick up	EUR 400,-
Between 59 days and 30 days before pick up	50% of total charges
Between 29 days and 1 day before pick up	85 % of total charges
On pick up day or no show	100 % of total charges

Transfers

There are no transfers possible for Rent Easy in Greece

Picking up/dropping of the vehicle

The motor home is delivered in a clean condition, with a full tank and equipped according to the inventory list submitted and must be returned in the same condition. If that is not the case, the Rental Firm shall be entitled to charge an amount for the cleaning of the interior. If the tank of the vehicle should not have been filled up, we charge the petrol costs as well as cost of work (€50). Any missing or defect items of the inventory list will be invoiced to you. Any possible retention will be set off against the security deposit.

Pickup will take place Monday to Friday in the afternoon, returns take place Monday to Friday in the morning. Saturday pickup and drop off are only possible by prior arrangement and will incur an additional charge.

Before taking the wheel, the Hirer is under an obligation to take part in a detailed introduction to the Vehicle by the Rental Company's experts at the collection center. On that occasion, there is drawn up a detailed report (Pick Up) of delivery describing the condition of the Vehicle that is to be signed by both parties. The Rental Company is entitled to refuse to hand over the Vehicle until this introduction has taken place. If handover is delayed due to the fault of the Hirer, he must bear any costs incurred as a result.

On returning the Vehicle, the Hirer is under an obligation to carry out a final examination of it together with rental station staff, with a written return report (Drop Off) to be prepared and signed by the Rental Company and the Hirer. Any damage not specified in the report of delivery that is detected upon return of the Vehicle shall be at the Hirer's expense.

Breakdown assistance and repair reimbursement

Repairs which become necessary to ensure the vehicle's operating and road safety may be commissioned by the renter up to a price of €150.00 without consultation; more extensive repairs may only be commissioned subject to the Rental company's approval.

If the renter ascertains a defect on the vehicle and omits to perform a repair which is required, the lessee shall nevertheless immediately notify the lessor of the defect and grant a reasonable period for the repair. The Rental company shall not be held accountable for country-specific circumstances (e.g. infrastructure) which delay the repair.

In the event of an accident

After an accident, theft or damage or damage during the ferry crossing by fire or collision with a wild animal, the police must be informed immediately and the rental station (for Telephone Number see rental contract), at the latest immediately after the working day following the day of the accident/incident. It is not permitted to accept any third-party claims as valid.

Even in the case of very slight damage, the Hirer must prepare a detailed written report for the Rental Company, including a sketch. If, for whatever reason, the Hirer fails to draw up such report and if, because of that, the insurance company refuses to pay the damage, the Hirer shall be obliged to pay full compensation for the damage.

The accident report must in particular include the names and addresses of anyone involved and any witnesses, together with the license numbers of all Vehicles involved and has to be over handed filled out and signed by drop off latest towards Rental Company.

In the case of theft the rental station reserves itself the right to calculate 10% of the value of the Vehicle up to a maximum of € 5.000.

Travel restrictions

Journeys abroad in Europe are allowed with prior permission. The use of ferries to certain islands may be subject to restrictions. The Hirer must inform themselves in advance about possible restrictions and driving bans.

The use of ferries to certain islands may be subject to restrictions. The Lessee is responsible for checking in advance for any restrictions or driving bans. Non-paved or difficult-toaccess roads on islands may be excluded from insurance coverage.

Parking/Traffic Violations

All costs incurred as a consequence of criminal activities or traffic offences committed by the hirer or a passenger will be collected by the hirer. Any fines imposed are charged to the hirer's account.

Pets and animals

Pets are allowed with Rent Easy, when mentioned and confirmed in advance

Smoking

Smoking is not allowed inside the Rent Easy vehicles
