

Rental conditions Rent Easy Netherlands

All rates and conditions are subject to change as required and without prior notification.

Standard inclusions

- 250 kilometer per day for short rentals
- Unlimited kilometers included for 15 days or more
- Deductible of € 1500,-
- Navigation
- Satelite dish, TV, Rear view-camera (except city)
- Bicycle rack (not suitable for e-bikes)
- Awning
- Outside cleaning

Camper is exclusive of

- Bed linen
- Dish set
- Towel set,
- Camping set (chairs and table)

Driver requirements

The prerequisite for hiring and driving the vehicle is a minimum age of 21 years. The minimum age for vehicles over 3.5 tonnes is 25 years. Both the lessee and all drivers shall have been in possession of a nationally valid driving licence required for driving the hired vehicle for at least one year – or for at least three years for vehicles over 3.5 tonnes. It is expressly pointed out that certain of the lessor's vehicles have a gross weight of more than 3.5 tonnes, and that driving these vehicles requires an appropriate driving licence. To make certain, holders of a Class B driving licence shall consult the lessor about the technically permissible gross weight of the vehicle rented by the lessee.

Deposit/credit card

The lessee shall pay the lessor a security deposit of €1,500.00. The security deposit shall be paid by EC card, MasterCard or Visa Card on collection of the vehicle at the latest. Payment of the security deposit with a credit-based pre-paid credit card or in cash is not possible.

Minimum rental period

There is a minimum of 7 nights

One-ways

There are no one ways possible within the Netherlands (hillegom is only location)

Changes

Up to a maximum of 30 days prior to the originally agreed start of rental, the lessee may select a vehicle from another vehicle group once only, if free capacities are available and as long as this does not reduce the total rental price. A handling fee of €50.00 per booking change will be charged for this. Booking changes at a later date are not possible. However, the lessee has the option of cancelling and then rebooking. There is no legal right to a change in the booking or in the data.

Cancellations

The charge for cancelling is:

61 days or more prior to pick up	30 % of total charges
Between 60 days and 31 days before pick up	50% of total charges
Between 31 days and 1 day before pick up	85 % of total charges
On pick up day or no show	100 % of total charges

Transfers

There are no transfers possible for Rent Easy in the Netherlands

Picking up/dropping of the vehicle

The motor home is delivered in a clean condition, with a full tank and equipped according to the inventory list submitted and must be returned in the same condition. If that is not the case, the Rental Firm shall be entitled to charge an amount for the cleaning of the interior. If the tank of the vehicle should not have been filled up, we charge the petrol costs as well as cost of work (€25). Any missing or defect items of the inventory list will be invoiced to you. Any possible retention will be set off against the security deposit. The pick up time is between 3.30-5pm, and drop off time is between 9-11am. For Saturday the pick up times are between 10-11am and drop off between 11am-12pm

Breakdown assistance and repair reimbursement

Repairs which become necessary to ensure the vehicle's operating and road safety may be commissioned by the lessee up to a price of €150.00 without consultation; more extensive repairs may only be commissioned subject to the lessor's approval.

If the lessee ascertains a defect on the vehicle and omits to perform a repair which is required, the lessee shall nevertheless immediately notify the lessor of the defect and grant a reasonable period for the repair. The lessor shall not be held accountable for country-specific circumstances (e.g. infrastructure) which delay the repair.

Travel restrictions

Trips abroad within Europe are possible. Trips to non-European countries require prior approval by the lessor. Trips to war zones or crisis areas are prohibited. The lessee/driver shall independently



obtain information on the traffic regulations and laws of the countries visited during the hire period as well as of any transit countries, and shall comply with the respective applicable traffic regulations

Parking/Traffic Violations

All costs incurred as a consequence of criminal activities or traffic offences committed by the hirer or a passenger will be collected by the hirer. Any fines imposed are charged to the hirer's account.

Pets and animals

Pets are allowed with Rent Easy, when mentioned and confirmed in advance

Smoking

Smoking is not allowed inside the Rent Easy vehicles
