Driver requirements

The prerequisite for hiring and driving the vehicle is a minimum age of 21 years. The minimum age for vehicles over 3.5 tonnes is 25 years. Both the lessee and all drivers shall have been in possession of a nationally valid driving licence required for driving the hired vehicle for at least one year – or for at least three years for vehicles over 3.5 tonnes. It is expressly pointed out that certain of the lessor's vehicles have a gross weight of more than 3.5 tonnes, and that driving these vehicles requires an appropriate driving licence. To make certain, holders of a Class B driving licence shall consult the lessor about the technically permissible gross weight of the vehicle rented by the lessee.

Deposit/credit card

The lessee shall pay the lessor a security deposit of NOK 10.000. The security deposit shall be paid by EC card, MasterCard or Visa Card on collection of the vehicle at the latest. Payment of the security deposit with a credit-based pre-paid credit card or in cash is not possible.

Minimum rental period

There is a minimum of 5 nights (depending on the booking season)

There are no one ways possible within Norway



Changes

Until 30 days before the originally agreed start of hire at the latest, the Hirer may choose a single time a vehicle from another vehicle group, as far as the Rental Firm disposes of respective free capacities and provided this does not reduce the total rental charge. In such case, a handling fee in an amount of NOK 210 per rebooking will be charged. A later change in the booking is not possible. However, the Hirer may cancel the booking and make a new booking. There is no legal right to a change in the booking or in the data.

Picking up/dropping of the vehicle

The motor home is delivered in a clean condition, with a full tank and equipped according to the inventory list submitted and must be returned in the same condition. If that is not the case, the Rental Firm shall be entitled to charge an amount for the cleaning of the interior. If the tank of the vehicle should not have been filled up, we charge the petrol costs as well as cost of work (NOK250). Any missing or defect items of the inventory list will be invoiced to you. Any possible retention will be set off against the security deposit.

- Bodø: The pick up time is Monday till Friday between 2-4pm, drop off time is between 8-10am, and for Saturday pick up is between 12-1pm and drop off is between 10-11am
- Kristiansand: The pick up time is Monday till Friday between 2-4pm, drop off time is between 9-10am, and for Saturday pick up is between 12-1pm and drop off is between 10-11am
- Oslo: The pick up time is Monday till Friday between 2-4pm, drop off time is between 8.30-10am, and for Saturday pick up is between 12-2 pm and drop off is between 10-11am
- Sarpsborg & Ålesund: The pick up time is Monday till Friday between 2-4pm, drop off time is between 9-10am, and for Saturday pick up is between 12-1pm and drop off is between 10-11am





Breakdown assistance and repair reimbursement

Repairs which become necessary in order to ensure the operating and roadworthy condition of the vehicle may be ordered by the Hirer up to NOK 1,500 without consultation, any major repairs may only be ordered after obtaining the consent of the Rental Firm. If the lessee ascertains a defect on the vehicle and omits to perform a repair which is required, the lessee shall nevertheless immediately notify the lessor of the defect and grant a reasonable period for the repair. The lessor shall not be held accountable for country-specific circumstances (e.g. infrastructure) which delay the repair.

Travel restrictions

Trips abroad within Europe are possible. Trips to countries outside Europe are subject to the prior approval of the Rental Firm. Trips to areas affected by war or crisis are prohibited. The Hirer /driver must independently inform himself /herself about the traffic regulations and laws of the countries visited during the hire period as well as of any transit countries and must comply with the respective applicable traffic regulations

Parking/Traffic Violations

All costs incurred as a consequence of criminal activities or traffic offences committed by the hirer or a passenger will be collected by the hirer. Any fines imposed are charged to the hirer's account.

Pets and animals

Pets are allowed with Rent Easy, when mentioned and confirmed in advance

Smoking

Smoking in not allowed inside the Rent Easy vehicles
